

## EXCHANGE SERVICE

2250.VOICE AND FEATURE BUNDLE (RESIDENTIAL)1. GENERAL

The Voice and Feature Bundle (Bundle) provides residential customers who choose the Company as either both their Local Exchange Carrier (LEC) and Primary Inter-exchange Carrier (PIC) or as their Local Exchange Carrier with residence service, including E9-1-1 service (E9-1-1) and Relay Service, and a choice of up to four calling features and/or forborne voice messaging services.

The Bundle offers customers with a choice of calling features and messaging services from the eligible list as specified in item 3 below. Any service charges specified in Item 510 that would otherwise be applicable are included in the Bundle.

2. SERVICE AND EQUIPMENT

A. The Bundle is available only to residential customers served by the Exchanges listed below and who have the Company as their LEC and PIC or as their LEC. C

B. The Bundle is offered on a monthly basis and is subject to a 90 day subscription period. Eligible residential customers will receive a fulfillment letter from the Company at the time of subscription. C

C. The rates and charges for the Bundle continue to apply if customers choose fewer than four calling features or voice messaging services.

D. Customers may change their choice of calling features or voice messaging services at no additional charge.

E. When a customer terminates or becomes ineligible for the service under the Bundle within the first 90 days of service, the customer's bill will be adjusted to reflect the difference between the service charges that apply to the service under the Bundle and the service charges that would otherwise have been applicable to the individual service components. Such billing adjustments will not apply to requests for changes made after the first 90 days of service.
