### 1. <u>SERVICE DESCRIPTION</u>

A. The following Business Local Exchange Services, as described in the Company's tariffs, are forborne from regulation in the Exchanges specified in Item 473.1.B and are subject to both the conditions set out in Telecom Decision CRTC 2006-15, *Forbearance from the regulation of retail local exchange services*, as amended by the Governor in Council's *Order Varying Telecom Decision CRTC 2006-15* P.C. 2007-532. In addition, all Business Local Exchange Services to be offered in the future that fall within the definition of local exchange services set out in Telecom Public Notice CRTC 2005-2, *Forbearance from regulation of local exchange services*, and Telecom Decision CRTC 2005-35, *List of services within the scope of the proceeding on forbearance from regulation of local exchange services*, (Decision 2005-35), as amended by Decision 2005-35-1, are also forborne from regulation in the Exchanges specified in Item 473.1.B.
