USE OF CUSTOMER PROVIDED EQUIPMENT WITH THE COMPANY FACILITIES

1. **GENERAL**

A. Equipment specified in Items 2820, 2830 and 2840 of this tariff shall only be affixed to the Company' facilities in accordance with the requirements stated herein or by special agreement with the Company.

Customer-provided equipment connected to the Company' facilities must meet the applicable technical standards of the Canadian Standards Association and Industry Canada relating to multiline terminal equipment, network protection devices and connection arrangements, unless otherwise stated in specific Tariff Items.

C. Such equipment, apparatus or devices must be suitable for operation or use with the Company' facilities, and must not create a hazard to the public, authorized the Company personnel or the Company facilities, as a result of its condition, location or source of power to which it is connected. The characteristics, operation and maintenance of such equipment, and the magnitude and character of the voltages and currents transmitted, must not cause or be likely to cause interference with services provided by the Company.

C

D. The customer shall not have, acquire, secure or derive any right in or control over the Company equipment, apparatus, lines, circuits or devices to which attachment is made. Except as otherwise provided in the General Tariff, the Company is solely responsible for the installation and maintenance of wiring inside customer premises, and the customer shall not add to, rearrange or modify any inside wiring or equipment. The Company reserves the right to change in whole or in part the design, function, operation or layout of its equipment, apparatus, lines, circuits or devices as it from time to time considers necessary. The Company does not represent that its facilities are satisfactory for the use of customer-provided equipment, apparatus or devices. The Company shall not be responsible to the customer for any equipment, apparatus or device which ceases to be compatible with the Company facilities or becomes inoperative because of changes to the Company equipment, apparatus, lines, circuits, devices, signaling or transmission mediums.

E. The Company, upon notice to the customer, may make such tests and inspections, as it C considers necessary to determine that its requirements are being complied with in the installation, operation and maintenance of customer-provided equipment. Upon notice from the Company that such equipment is causing or is likely to cause hazard or interference, the customer shall arrange for such changes as are necessary to remove or prevent such hazard or interference. The Company may, at any time, interrupt or terminate the connection if, in the Company's judgment, such action is necessary to protect the public or the Company's employees or facilities and services.
