### Implementation of thousand-block pooling

In Telecom Order CRTC 2025-240, the Commission approved changes to the wording in Item 1270 of its Nova Scotia General Tariff to accommodate the Commission's determinations concerning thousand-block pooling in Telecom Regulatory Policy 2024-26 to ensure that a carrier's request for numbers will only be provided where forecasts warrant.
