Item 307 INTER-OFFICE DIGITAL CHANNELS

**Service Description 307.1** Inter-Office Digital Channels are furnished between wire centres and/or rate centres of Carriers or between rate centres of Carriers and other rate centres or international border crossing points in Canada for the digital transmission of information.

For Competitive Canadian Carriers, Wireless Service Providers or Resellers, Bell Canada's Access Services Tariff Item 130 or Bell Aliant General Tariff, CRTC 21491, Item 612 apply, as appropriate.

This Item applies to **Bell** and **Bell Aliant**.

Inter-Office Digital Channels are forborne from regulation, pursuant to Telecom Decision CRTC 97-20, when provided on the cross-sections identified in Item 16.

Effective 7 March 2024, DS-0 Inter-exchange Channels are destandardized except for the interconnection purposes listed below. Existing customers may maintain their existing DS-0 Inter-exchange Channels however requests for moves, adds or changes to existing DS-0 Inter-exchange Channels will not be processed. DS-0 Inter-exchange Channels are not available for new installations, except when used for interconnection pursuant to a Master Agreement for Local Interconnection between the Customer and the Company, or for connection between the Customer's point of presence and the Company's network for the purposes of obtaining any of the Company's interconnection services (toll, local, wireless and transiting services) set out in Telecom Decision CRTC 2008-17, Appendix, Category (e); or for the purposes of connecting to a Central Office co-location space established pursuant to the Company's tariffs.

### Item 307 INTER-OFFICE DIGITAL CHANNELS

#### Definitions 307.2

"*Cross-section*" refers to the DS-0, DS-1 and DS-3 channels furnished between a Carrier's Wire Centres or Rate Centres, between Carriers' Rate Centres or between a Carrier's Rate Centre and an international border crossing point in Canada. C

"*Inter-exchange Channels*" refers to the digital facilities required to connect Wire Centres or Rate Centres of different Exchanges or an international border crossing point in Canada. C  
C

"*Route Diversity*" is provided, where facilities exist, when a customer requests an additional channel between the same two locations and requires that the channel follows a different route than the first channel.

### INTER-OFFICE DIGITAL CHANNELS

#### Terms and Conditions 307.3

- (a) The Carrier determines the exchanges where service will be provided. C
  - (b) Service is provided at the Carrier's discretion within or between exchanges, depending on the availability of suitable facilities and equipment. C
  - (c) Digital channels may be connected to other Carrier services or with the services and/ or facilities of other carriers. C
  - (d) Inter-office digital channels are available under a Customer Volume Pricing Plan (CVPP) as specified in Item 306. Discounts are based on the term and the minimum monthly billing commitment. Inter-office digital channels are also available on a one-month non-contracted basis.
  - (e) Route diversity, where available, may be provided on request to ensure that specified groups of channels in a cross-section are maintained on separate facility structures.
  - (f) Channel distance is calculated as defined in Item 300.2.
  - (g) Total distance charges per inter-exchange channel are calculated by multiplying the mileage by the charge per mile for the appropriate distance band and adding the base charge for that band.
