Description
704.1**

(a) This arrangement provides the Central Office equipment and facilities necessary for the interconnection of Mobile Satellite Ventures Corp. (MSV) mobile satellite network with the Carriers' Public Switched Telephone Network (PSTN). MSV has been designated by Industry Canada to operate a mobile satellite communications system (MSAT). This service is subject to the availability of suitable facilities. MSV's equipment shall meet the specifications as established by Industry Canada. Mobile Satellite Access Service consists of the following: C

(1) Access Numbers: Seven-digit telephone numbers with outpulsing assigned from an appropriately equipped line-serving switch. Access numbers are provided as a dedicated group of 10,000 consecutive telephone numbers (an entire NXX). A one-time charge applies to open an NXX in the 600 Service Access Code (SAC) across the Carriers' network. A service charge applies to activate each 600 NXX code, assigned to MSV by Industry Canada, in Bell Canada's serving Wire Centre. Charges per 10,000 access numbers are specified in Item 704.3 (a)(1) a. and b. C

(2) Link: Link provides the Wire Centre equipment required to terminate a digital Access Channel in Bell Canada's line-serving switch Wire Centre. A Link is associated with each Access Channel and is provided at the rate specified in Item 704.3 (a)(2). C

Service Description 704.1

(a) This arrangement provides the Central Office equipment and facilities necessary for the interconnection of Mobile Satellite Ventures Corp. (MSV) mobile satellite network with the Carriers' Public Switched Telephone Network (PSTN). - continued C

(3) Access Channel: A digital Access Channel is provided over a facility derived from Digital Private Line Service (National Services Tariff Item 302.3). Such a system provides 24 digital access channels between the line-serving switch Wire Centre and MSV's Mobile Telephone Exchange (MTX). C

(4) 600 MSV Network Service: This network service allows MSV to receive and be billed for 1-600-70X incoming calls to the interconnected MSV network from Canadian NPAs.

600 MSV Network Service rate is specified in Item 704.3 (a)(4).

(a) Rates for Mobile Satellite Access Service as specified below - continued

A monthly minimum billed usage charge based on 40,000 minutes applies.

Calls originating in the local calling area of MSV 600 number will be billed at \$0.0673 per minute. **R**

Calls which originate within the local calling area of a MSV 600 number are included in the total monthly usage minutes to determine the appropriate per minute rate.

A one-time billing service charge of \$586,579.04 applies to either 600 MSV Network Service option. **R**

For alternate service providers requiring equivalent access, a one-time charge of \$239,796.47 is applicable for each 600 NXX opened in the Carriers' Network. In addition, the appropriate Switching and Aggregation and Contribution interconnection charges as stated in the Carriers' Access Services Tariff for Interconnection with Interexchange Carriers (IXC's) apply. **R**
